

IMPORTANT NOTES before Logging onto AJIS

- AJIS may be accessed using latest version of Internet Explorer, Chrome for Windows, or Firefox for Windows. AJIS has not been tested thoroughly when using these browsers with Mac OS and may or may not function correctly when accessing AJIS from a Mac, iPad, tablet or other mobile device.




- Viewing documents requires the use of a PDF reader such as Adobe Reader or another compatible PDF reader. Pop-up blockers may prevent the PDF reader from displaying the separate document window. If you receive a message that a pop-up was blocked, disable the pop-up blocker when accessing AJIS.



LOGGING IN for Paid Access Subscribers and Free Access users

- For Paid Access Subscribers, type your Username and Password under Existing Subscriber Login and press the GO button.
- Free Access users may press the GO button in the Free Access box. There is no Username or Password for Free Access users.
- Once logged on, AJIS will open and the Function List will appear on the left. For more information on the Function List, see [AJIS NAVIGATION](#) later in these instructions.

AJIS NAVIGATION

After logging on to AJIS, the screen will look similar to the one on the right displaying the main function list. Searching and viewing data always begins with the Function List. WORKING WITH SEARCH & LIST PAGES

Searching for data is accomplished using Search & List pages that allow you to enter search criteria on search form page and display a list of matching results on the following page.
